However, the abstract needs to be more concise, and the methods and results are too redundant. The number is unclear, and its magnification should be marked. Between the two groups, can compare the baseline demographic characteristics. The questions raised by the reviewers should be answered; (3) Format: There are 4 Figures; (4) References: A total of 28 references are cited, including 4 references published in the last 3 years; and (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (6) I found the authors did not write the "article highlight" section.
