Science Editor: 1 Scientific quality: The manuscript characterizes the relationship between ketonic bodies production, weight loss and metabolic changes following bariatric surgery. The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors show that the younger patients with worse metabolic status after bariatric metabolic surgery had lower weight loss. The correlation of ketogenesis with respect to weight loss is very well stated. The study also correlated the ketogenesis with age of the patients which was also an interesting research area. The questions raised by the reviewers should be answered; (3) Format: There are 3 tables and 2 figures; (4) References: A total of 45 references are cited, including 7 references published in the last 3 years; (5) Self-cited references: Self-cited references are not detected because the references are not complete with all authors. (6) References recommendations: The authors citation is an acceptable range. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Informed Consent Form, and the Institutional Review Board Approval Form is correctly provided. No academic misconduct was found by the Google/Bing search. However, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement is not provided. 4 Supplementary comments: This is an invited manuscript. No
