The topic has not previously been published in the World Journal of Gastrointestinal Oncology. 5 Issues raised: (1) The title is too long, and it should be no more than 18 words; (2) Please check the language corrections in yellow highlighted words and passages; (3) Revise the number of words in the "Abstract" section; (4) References: Please provide doi and PMID.
