(1) Classification: Grade A and Grade B; (2) Summary of the Peer-Review Report: This manuscript is very interesting. Please check the language corrections in yellow highlighted words and passages. (3) Format: There are 4 figures and 1 table; (4) References: A total of 48 references are cited, including 24 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; (6) References recommendations: There are no references recommended by the peer reviewers. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: Institutional Animal Care and Use Committee Approval Document and Institutional Review Board Approval Document were not in English language. No academic misconduct was found by the Google/Bing search. 4 Supplementary comments: The study was supported by National Natural Science Foundation of China and the Natural Science Foundation of Hunan Province. The topic has not previously been published in the World Journal of Gastrointestinal Oncology. 5 Issues raised: (1) The title is too long, and it should be no more than 18 words; (2) Please check the language corrections in yellow highlighted words and passages; (3) Revise the number of words in the "Abstract" section; (4) References: Please provide doi and PMID. 6 Re-Review: Not required/Not required. 7 Recommendation: Conditional acceptance.
