The methodological section was somewhat inadequate and the manuscript is lack of imaging results compared with other studies The questions raised by the reviewers should be answered; (3) Format: There are 5 tables and 3 figures; (4) References: A total of 52 references are cited, including 6 references published in the last 3 years; (5) Self-cited references: There are 4 self-cited references. 2 Language evaluation: Classification: Grade B, B and B. The manuscript is reviewed by a native English speaker.

3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form number. No academic misconduct was found in the Bing search. 4 Supplementary comments: No financial support was obtained for the study. The topic has not previously been published in the WJP. 5 Issues raised: (1) The “Author Contributions” section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents.
