**Science Editor:** 1 Scientific quality: The manuscript describes a case report of the diffuse large B cell lymphoma originating from the maxillary sinus with skin metastases. The topic is within the scope of the WJCC. (1) Classification: Four Grades C; (2) Summary of the Peer-Review Report: This is an interesting case report of lymphoma of maxillary sinus with multiple metastasis including uncommon cutaneous areas. The questions raised by the reviewers should be answered; (3) Format: There is 1 table and 6 figures; (4) References: A total of 40 references are cited, including 5 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Three Grades B and Grade C.
