2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a Case Control Study of the fast-track protocols in laparoscopic liver surgery. The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: It is clinically significant and new to the extent of some degree. The manuscript should be concise and much syntax should be polished. The data of operated patients were missing, major or minor resections were invisible, so conclusion is not evidenced. The questions raised by the reviewers should be answered; (3) Format: There are 2 tables and 5 figures; (4) References: A total of 22 references are cited, including 2 references published in the last 3 years; (5) Self-cited references: There are 5 self-cited references. There is no self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study.
