The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors evaluated the efficacies of serum G-17, PGI, PGII, and</p>	[Y]

PGI/PGII ratio (PGR) for predicting upper gastrointestinal bleeding among peptic ulcer patients. The idea is good, the aim was clear, the work was sufficient to achieve the aim with impressive conclusion. However, the questions raised by the reviewer should be answered; and (3) Format: There are 3 tables and 2 figures. (4) References: A total of 18 references are cited, including 5 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves. If the authors found the peer reviewer(s) request the authors to cite improper references published by themselves, please send the peer reviewer's ID number to the editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade C. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, Written informed consent and the STROBE Statement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJG. 5 Issues raised: (1) The language classification is Grade C. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (6) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text; and (7) The scientific quality can’t meet the requirement of WJG. 6 Recommendation: Transferring to the WJCC.</p> <p>Company Editor-in-Chief: I recommend the manuscript to be published in the World Journal of Clinical Cases.</p>
