The questions raised by the reviewers should be answered; (3) Format: There are 1 tables and 1 figure; (4) References: A total of 27 references are cited, including 7 references published in the last 3 years; (5) Self-cited references: There are 5 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations (kindly remind): The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). Please add the "Article Highlights" section at the end of the main text; (5) The authors need to fill out the STROBE checklist with page numbers. 6 Recommendation: Conditional acceptance.
