The questions raised by the reviewers should be answered; (3) Format: There are 4 tables and 6 figures; (4) References: A total of 42 references are cited, including 9 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited references. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by AJE was provided. The authors are native English speakers. The manuscript is reviewed by a native English speaker. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form and STROBE Statement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; (3) Please upload the primary version (PDF) of the Informed Consent Form (Surgical procedures or other) that has been signed by the patients in the study, prepared in the official language of the authors' country to the system; for example, authors from China should upload the
