part could be more detailed. The questions raised by the reviewers should be answered; (3) Format: There are 5 figures; (4) References: A total of 11 references are cited, including 1 reference published in the last 3 years; (5) Self-cited references: There is no self-cited reference. 2 Language evaluation: Classification: Grade C and Grade C. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Written informed consent and CARE Checklist (2016). No academic misconduct was found in the Bing search. 4 Supplementary comments: The study was supported by Zhejiang Provincial Medical Science Research Foundation. The topic has not previously been published in the WJGS. 5 Issues raised: (1) Please provide the English language editing certificate issued by the language editing company; (2) Please provide manuscript in MS Word format, and the manuscript in any other format will be rejected; (3) The "Author Contributions" section is missing. Please provide the author contributions; (4) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (5) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. Uniform presentation should be used for figures showing the same or similar contents (using lettered panels); for example: "Figure 1 Pathological changes
