Science Editor: 1 Scientific quality: The manuscript describes a retrospective cohort study of the all-epiphyseal versus trans-epiphyseal screw fixation for tillaux fractures. The topic is within the scope of the WJO. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: This study is overall good. The questions raised by the reviewers should be answered; (3) Format: There are 3 tables and 2 figures; (4) References: A total of 24 references are cited, including 4 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com.
