The topic is within the scope of the WJG. (1) Classification: Grade A and Grade C; (2) Summary of the Peer-Review Report: The manuscript was well written, the authors used important and novel references. Authors should provide more</p>	[Y]

details of evaluation of fibrosis using a non-invasive assessment. The questions raised by the reviewers should be answered; (3) Format: There are 3 tables; (4) References: A total of 44 references are cited, including 9 references published in the last 3 years; (5) Self-cited references: There are 5 self-cited references. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated. 2 Language evaluation: Classification: Grade A and Grade B. The manuscript is reviewed by a native English speaker. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form and the Written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJG. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; (3) For PMID and DOI numbers of references from English-language journals, please ensure there is a space between the PMID and DOI numbers in the square brackets. PMCID numbers are not required. 6 Recommendation: Conditional
