Science Editor: 1 Scientific quality: The manuscript describes a Minireview of the therapeutic manipulation of co-stimulatory molecules. The topic is within the scope of the WJI. (1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: The article provides a brief overview on different aspects of co-stimulatory molecules. There are only few grammatical errors. The questions raised by the reviewers should be answered; (3) Format: There are 5 tables and 2 figures; (4) References: A total of 33 references are cited; (5) Self-cited references: There is no self-cited reference. 2 Language evaluation: Classification: Grade B and Grade C. The manuscript is reviewed by a native English speaker. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Institute of Ophthalmology "Conde de Valenciana". The topic has not previously been published in the WJI. 5 Issues raised: (1) The language classification is Grade C.
