Also, the corresponding reference should be added in the text. The introduction must be improved reporting a brief introduction of the topic and the aim of the study. "The advantages of laparoscopy are as follows" are useless. Please focus on the main topic. The figures need to be arranged. The surgical technique must be explained fluently and not in separate sentences. The discussion must be improved. What are the clinical implications?
