Science Editor: 1 Scientific quality: The manuscript describes a minireview of the renoprotective role of amlodipine in patients with hypertensive chronic kidney disease. The topic is within the scope of the WJN. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: In this manuscript, author sought to investigate the renoprotective role of amlodipine in patients with hypertensive chronic kidney disease. This manuscript is an interesting study. The questions raised by the reviewers should be answered; (3) Format: There is 1 table and 5 figures; (4) References: A total of 54 references are cited, including 8 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
