well written, but the questions raised by the reviewers should be answered; (3) Format: No tables or figures; (4) References: A total of 88 references are cited; (5) Self-cited references: There are 3 self-cited references; (6) References recommendations: None. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors declare no conflicts of interest. No academic misconduct was found by the Google/Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by the Specialty School of General Surgery of the University of Catania and by the FIR-14 Research Project of the University of Catania. The topic has not previously been published in the WJD. 5 Issues raised: (1) The abstract is far less than 200 words. (2) The key words are in excess of the given limit. (3) The first letter of "many" should be capitalized in Core tip; (4) Reference format in the main text should be [1] instead of [1]; (5) In References, PMID should be in front of DOI; "doi" should be capitalized; Please delete "https://" in Ref 1 and 2. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance after minor revision.
