The topic is within the scope of the WJP. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This is a very important contribution. The</p>	[Y]

authors' data suggest that the coping strategies adopted during the first wave of the SARS-CoV-2 pandemic protected the population from the general risk of "psychopathological decompensation". The questions raised by the reviewers should be answered; (3) Format: There are 5 tables; (4) References: A total of 48 references are cited, including 46 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors didn't provide the biostatistics Review Certificate, the Institutional Review Board Approval Form, and the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary

comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJP. 5 Issues raised: (1) The title is too long, and it should be no more than 18 words; (2) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
