The questions raised by the reviewers should be answered; (3) Format: There are 3 tables and 4 figures; (4) References: A total of 99 references are cited, including 30 references published in the last 3 years; and (5) Self-cited references: There are 4 self-cited reference. 2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJC. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the Figures cited in the original manuscript in the form of PPT. All text can be edited, including A, B, arrows, etc. With respect to the reference to the Figure, determine if it is the original Figure, if not, please provide the source of the picture and the proof that the Figure has been authorized by the previous publisher or copyright owner to allow it to be redistributed.; (2) References 60 and 62 are duplicated, 84 and 91 are duplicated, please modify, and cite the references in order; (3) There are less than 100 references, so you need to modify the manuscript type to Minireviews; and (4) Please write the "Conclusion" section at the end of the main text. 6 Recommendation: Conditionally accepted.
