The topic is within the scope of the WJH. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The manuscript is well written describing each characteristics of metabolic disease separately. figures and typos need to be adjusted. The questions raised by the reviewers should be answered; (3) Format: There are 3 figures; (4) References: A total of 98 references are cited, including 18 references published in the last 3 years; and (5) Self-cited references: There is no self-cited reference. 2 Language evaluation: Classification: Grade B and Grade A. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJH. 5 Issues raised: (1) All the author's institution information needs to provide a postcode. The corresponding author needs to provide more detailed address information, such as street information; (2) I found the authors did not provide the original figures. Please provide the Figures cited in the original manuscript in the form of PPT. All text can be edited, including A, B, arrows, etc. With respect to the reference to the Figure, determine if it is the original Figure, if not, please provide the source of the picture and the proof that the Figure has been authorized by the previous publisher or copyright owner to allow it to be redistributed; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) the author should number the references in Arabic numerals according to the citation order in the text. The
