the peer reviewer raised the following queries- 1. Inclusion of a literature search criteria. 2. The English language improvement. 3. Some rewriting needed. The questions raised by the reviewers should be answered; The manuscript has 4 tables and no figures. A total of 145 references are cited, including 15 citations published within the last 3 years. There are 3 self-citations. The self-referencing rate should be less than 10%. Presently its 2.07%. The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially those published by the peer reviewer(s) him/herself (themselves).
