A language editing certificate issued by LebPub was provided. 3 Academic norms and rules: The authors provided the Written informed consent and CARE Checklist (2016). No academic misconduct was found in the Bing search. 4 Supplementary comments: The study was supported by Non-profit Central Research Institute Fund of Chinese Academy of Medical Sciences and the Project Management Fund for Foreign Cultural and Educational experts.
