2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the Value of Neutrophil-lymphocyte ratio in evaluating response to percutaneous catheter drainage in patients with acute pancreatitis. The topic is within the scope of the WJG. (1) Classification: Grade B and Grade D; (2) Summary of the Peer-Review Report: The authors found that WBC and NLR can be used as simple tests for predicting response to PCD in patients with ANP. However, the study has several concerns raised by the reviewers. Therefore, the questions raised by the reviewers should be answered; (3) Format: There are 4 tables and 4 figures; (4) References: A total of 45 references are cited, including 12 references published in the last 3 years; (5) Self-cited references: There are 7 self-cited references. The self-referencing rate should be less than 10%. Please keep the reasonable self-citations (i.e., those which are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate was not provided as the authors are native English speakers (India). 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright</p>	[Y]
