**Science Editor:** 1 Scientific quality: The manuscript describes a minireview of the role of genetic testing in cardiomyopathies. The topic is within the scope of the WJC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The manuscript reviewed the genetic testing in cardiomyopathies. It provides very useful information for understanding the application of genetic testing in cardiomyopathy. However, the presentation of genetic testing methods and the genetic testing methods commonly used in different cardiomyopathy is very limited in the full manuscript. Therefore, it is suggested to supplement the content of genetic testing techniques and the application of each method; (3) Format: There are 3 tables; (4) References: A total of 51 references are cited, including 2 references published in the last 3 years; (5) Self-cited references: There are no self-citations; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
