The topic is within the scope of the WJG. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The case report is well written structurally and stylistically. condition. However, the authors should report your treatment plan for recurrent retroperitoneal lymph node after 24 months of follow-up; and (3) Format: There are 5 figures. (4) References: A total of 17 references are cited, including 5 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
