The material studied is large enough and allows to draw the conclusions. It is recommended that only the key data be displayed in the results section of the summary, and other secondary results should be described in text. The discussion part is suggested to be improved. The questions raised by the reviewers should be answered; (3) Format: There are 5 tables; (4) References: A total of 20 references are cited, including 8 references published in the last 3 years; and (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). Please write the “article highlights” section at the end of the main text; and (4) Please write the “Conclusion” section at the end of the main text. 6 Recommendation: Conditionally accepted.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, the full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Clinical Cases, and the manuscript is conditionally accepted.
