2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case report of the transient ventricular arrhythmia as a rare cause of dizziness during exercise. The topic is within the scope of the WJCC. (1) Classification: Grade A; (2) Summary of the Peer-Review Report: Excellent report with a perfect balance of details and conclusions. However, there are two issues that need to be resolved. Regarding the term semi-spontaneous nystagmus, it is not clear</p>	[Y]

whether it refers to positional or kinesthetic nystagmus. In addition, the report on heart palpitations is a bit unclear. The questions raised by the reviewers should be answered; (3) Format: There are 2 figures; (4) References: A total of 13 references are cited, including 2 references published in the last 3 years; and (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade A. A language editing certificate issued was provided. 3 Academic norms and rules: The authors provided the CARE Checklist and Written informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the Fujian Provincial Health Commission; National Natural Science Foundation of China; and Natural Science Foundation of the Fujian Province. The topic has not previously been published in the WJCC. 5 Issues raised: (1) I found the

authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the "Case Presentation" did not meet our requirements. Please re-write the "Case Presentation" section. 6 Recommendation: Conditionally accepted.
