The topic is within the scope of the WJCC. (1) Classification: Grade C and Grade C; (2) Summary of the Peer-Review Report: This is a very interesting case that illustrates the value of echocardiography in IE with BCNIE. disease, IV immunoglobulin and aspirin are the treatments, so it would be good to describe why the treatment has changed. The questions raised by the reviewers should be answered; (3) Format: There are 2 figures; (4) References: A total of 29 references are cited, including 1 reference published in the last 3 years; (5) Self-cited references: There are no self-citations; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
