The questions raised by the reviewers should be answered; (3) Format: There are 2 figures; (4) References: A total of 34 references are cited, including 9 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, Written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Yunnan Provincial Health Committee Senior Talent Project, International Science and Technology Cooperation Special Key Research and Development Plan and Academician Expert Workstation of Yunnan Province. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The "Author Contributions" section is missing.
