The topic is within the scope of the WJCC. (1) Classification: Grade D, Grade E, and five Grade C; (2) Summary of the Peer-Review Report: In general, the subject quite interesting and the present</p>	[ Y ]

manifestation quite rare. There are a lot of issues regarding grammar, terminology and English language in general. The authors need to add more details in the “case presentation” section. The questions raised by the reviewers should be answered; and (3) Format: There are 5 figures. (4) References: A total of 33 references are cited, including 5 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer’s ID number to editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Four Grade B, three Grade C. A language editing certificate issued by editage was provided. 3 Academic norms and rules: The authors provided the CARE checklist and informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures

using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; And (2) I found the “Case Presentation” did not meet our requirements. Please re-write the “Case Presentation” section, and add “FINAL DIAGNOSIS”, “TREATMENT”, and “OUTCOME AND FOLLOW-UP” section to the main text, according to the Guidelines and Requirements for Manuscript Revision; (10) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author’s name, with no spaces. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
