Peer-Review Report: This study is well designed. The methods are clearly described. The inclusion and exclusion criteria are reasonable. The results are discussed with updated references. The questions raised by the reviewers should be answered; (3) Format: There are 6 tables and 1 figure; (4) References: A total of 20 references are cited, including 15 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com.
