letter to the editor of the evaluation of an asymptomatic Covid-19 post-surgery with chest radiography. The topic is within the scope of the WJV. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The clinical viewpoint of this manuscript should be emphasized. Although this manuscript has some ambiguity regarding their opinions and rationale, the trend towards undertreatment should be alarmed. The questions raised by the reviewers should be answered; (3) Format: There are no tables and no figures; (4) References: A total of 9 references are cited, including 6 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com.
