Specific Comments to Authors: This manuscript deals with almost all possible liver diseases and their injuries, e.g., NAFLD, MAFLD, Alcoholic liver disease, Alcohol-related liver disease, Autoimmune diseases (AIH, PBC, and PSC), Viral Hepatitis (HCV, HBV), Cirrhosis, HCC, Liver transplantation, Moreover, it also reviews about the prioritization of COVID19 vaccination having liver diseases and injuries. The authors also have thoroughly shed light on dealing with COVID-19 patients having hepatic injuries and complications. The authors have brought an excellent review to the concerned field. The review is a comprehensive and well-written manuscript and has the potential to be accepted.

Some aspects of the manuscript should be revised according to the mini-review format and editorial rules (see issues raised) (4) References: A total of 76 references are cited. (5) Self-cited references: there are no self-cited references. 2 Language evaluation: Grade A. 3 Academic norms and rules: no major issues after Google search. 4 Supplementary comments: This is an invited manuscript. 5 Issues raised: - the use of the abbreviations, especially in the subheadings must be revised and improved. In general, a revision of the manuscript structure to make it be appropriate to the mini-review format, is recommended. - COI form is missing - the references style as well as the citations in the text must be formatted according to the journal policy. - Non-Native Speakers of English Editing Certificate is not appropriate. - there are no tables or figures. The authors should complete the mini-review with appropriate table(s) and/or figure(s). - there are several and recent papers discussing the effects of COVID-19 on the liver: the authors should highlight the novelty of their manuscript. I would suggest improving the title as well, taking in account the previous comment. 6 Re-Review: YES 7 Recommendation: Transfer to World Journal of Hepatology.
