(1) Classification: Two Grades C; (2) Summary of the Peer-Review Report: This is a well-researched review that brings together the evidence for myelin dysfunction in schizophrenia and bipolar disorder. The discussion about the features common to both the disorders such as psychosis, cognitive impairment, shared genes, and similar brain abnormalities provides an appropriate background to the topic of myelin dysfunction in these two disorders. The mention of the disconnection hypothesis was also very useful. The questions raised by the reviewers should be answered; (3) Format: There is 1 table and 4 figures; (4) References: A total of 194 references are cited, including 62 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
