prognostic marker, however, this should be incorporated in a broader list of other risk factors. I have few comments. Reviewer 2: This is a well-conducted study that addresses an interesting problem using an emerging research method (radiomics / machine learning) with relevant results. I have only minor comments. (3) Format: There are 4 tables and 4 figures (4) References: A total of 27 references are cited, including 14 references published in the last 3 years; 2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: No academic misconduct was found by the Google/Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. 5 Comments by Academic Editor: 1) Authors should read the WJG article formatting rules. The article is out of the rules. <https://www.wjgnet.com/bpg/GerInfo/211> 2) Do not use abbreviations in the title and in Coretip. 3) The authors did not provide original pictures. Please provide the original figure files. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; 4) Tables must be sent separately. At the end of the article, there should be a topic "tables and figures Legends" 6 Re-Review: Required 7 Recommendation: The article did not reach the WJG publication grades (A+A, A+B, B+B, B+A). I suggest transferring to World Journal of Radiology
