The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This is a very interesting case report with some clinical guidance. The reviewer has two questions. 1. Did PET-CT not find this</p>	[Y]

transferred skeletal muscle? 2. Do you think surgical removal of metastases is more beneficial to patients? Please provide a reasonable explanation and explain the lessons learned from the treatment plan in this case. The questions raised by the reviewers should be answered; (3) Format: There are 1 table and 3 figures; (4) References: A total of 35 references are cited, including 2 references published in the last 3 years; and (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) I found the authors did not add the PMID in the reference list. Please provide the PubMed numbers citation numbers to the reference list and list all authors of the references. Please revise throughout; and (5) I found the "Case Presentation" did not meet our requirements. Please re-write the "Case Presentation" section, and add "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" section to the main text, according to the Guidelines and Requirements for Manuscript Revision. 6 Recommendation: Conditionally accepted.
