2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a case control study of the tissue doppler, speckling tracking and four-dimensional echocardiographic assessment of right ventricular function in children with dilated cardiomyopathy. The topic is within the scope of the WJCP. (1) Classification: Grade A; (2) Summary of the Peer-Review Report: Their results showed that impairment of the RV global longitudinal strains and other systolic and diastolic parameters in children with DCM. It is a good story. The questions raised by the reviewers should be answered; (3) Format: There are 3 tables and 5 figures; (4) References: A total of 36 references are cited, including 3 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
