In addition, the authors ignored the requirements for the formulation of quotations (e.g.,no DOI and no PUBMED IDs).Results section requires significant revision. The questions raised by the reviewers should be answered; (3) Format: There are 4 tables and 6 figures; (4) References: A total of 52 references are cited, including 16 references published in the last 3 years; (5) Self-cited references: There are no self-cited references. 2 Language evaluation: Classification: Grade B and Grade C. A language editing certificate was provided, but the reviewer found grammatical errors in the manuscript. Please check the English language in the services recommended by the WJG. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and did not provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. Please, provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found by the Google search. 4 Supplementary comments: This is an unsolicited Manuscript. The topic has not previously been published in the WJG. 5 Issues raised: (1) The key word "systematic review" is missing in the title. Please add it; (2)
