<b>Patient Information</b>	<b>6a</b>	De-identified demographic and other patient or client specific information	<u>line16/page4</u>

	<b>8d</b>	Prognostic characteristics where applicable	<u>none</u>
<b>Interventions</b>	<b>9a</b>	Types such as life-style recommendations, treatments, medications, surgery	<u>line10-14/page7</u>
