Report: This is a rare case report. If the CT had been taken up to the pelvis for the first time, it would have been diagnosed earlier. Please indicate the severity of acute pancreatitis according to the revised Atlanta classification; (3) Format: There are 2 tables and 3 figures; (4) References: A total of 37 references are cited, including 8 references published in the last 3 years; (5) Self-cited references: There are no self-citations; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
