The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: Reviewer suggested a variety of major and minor corrections in a word file, and suggest reducing the number of authors. Therefore, there is huge room for improvement. The questions raised by the reviewer should be answered; (3) Format: There are 2 tables and 0 figures; (4) References: A total of 29 references are cited, including 26 references published in the last 3 years; (5) Self-cited references: There are 2 self-cited references for the first author. The self-referencing rate should be less than 10%. Please keep the reasonable self-citations (i.e. those which are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially those published by the peer reviewer(s) him/herself (themselves).
