The topic is within the scope of the WJO. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The subject studied by the authors is of great relevance since periprosthetic infection is a devastating complication in patients with proximal femur fractures, often elderly, institutionalized and affected by multiple comorbidities. The questions raised by the reviewers should be answered; (3) Format: There are 2 tables and 1 figure; (4) References: A total of 28 references are cited, including 16 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
