(2) Summary of the Peer-Review Report: 1) The abbreviation should be written in full at the first time. 2) The introduction should be revised according to reviewers. 3) The Materials and Methods should be revised according to reviewers; 4) Results should be check and revise according to reviewers; 5)Figures should be revised; 6) Discussion revised according to reviewers.7) In Table 1, the authors should mention the numbers of males and females in each group. (3) Format: There are 2 figures and 1 table. (4) References: A total of 41 references are cited, including 3 references published in the last 3 years; (5) Self-cited references: There in no self-cited references. 2. Language evaluation: Classification: Grade B. The author supplies language editing certificate. 3. Academic norms and rules: The Conflict-of-Interest Disclosure Form, the signed Informed Consent Form, the Biostatistics Review Certificate, the Institutional Review Board Approval Form are provided. No academic misconduct was found by the Google/Bing search. 4. Supplementary comments: This is unsolicited Manuscript manuscript. The study was no fund supported.
