2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes an Observational Study of the serum calcium, albumin, globulin and matrix metalloproteinase-9 levels in acute cerebral infarction patients. The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This study discussed the relationship between serum calcium,</p>	[Y]

albumin, globulin and MPP-9 levels and the occurrence of hemorrhagic transformation after IVT and the association between these factors and the early prognosis to reduce the risk for hemorrhagic transformation after IVT under early intervention by predicting the factors influencing its occurrence and prognosis in patients with acute cerebral infarction. Overall, this study is very interesting. The methods are clearly described and the results are reasonable. The questions raised by the reviewers should be answered; (3) Format: There are 3 tables; (4) References: A total of 21 references are cited, including 14 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
