Science Editor: 1 Scientific quality: This study investigated the differences in the clinical features of gastrointestinal (GI) immune-related adverse events in patients with non-small cell lung cancer (NSCLC) and malignant melanoma (MM) receiving immune checkpoint inhibitors. (anti-PD-1/anti-PD-L1 antibodies, anti-CTLA-4 antibodies), or combination therapy (anti-PD-1 and anti-CTLA-4 antibodies). It is observed that GI immune-related adverse events are more frequently observed in patients receiving anti-CTLA-4 antibodies than those receiving anti-PD-1/PD-L1 antibodies. MM patients continuing ICI treatment have a significantly prolonged OS. The topic is within the scope of the WJG. No financial support was obtained for the study. The topic has not previously been published in the WJG. 5 Issues raised: (1) Please provide the original figure files. Please prepare and arrange the figures using PowerPoint to ensure that all
