Dear Author Thank you for this presentation. My comment as follow: In this study, the authors prepared a literature review on PEComa disease originating from the colorectal region. In my opinion, in order for your article to be published in such a quality journal, it should be stated how this literature review was done in the abstract and methodology section of the article. For the article layout I want to explain, you can use some of the article formats published in the WJG series (I don't mean to refer to these studies): [World J Gastroenterol. 2010 Nov 28;16(44):5598-602--- World J Gastrointest Surg. 2014 Oct 27;6(10):190-200-- World J Gastrointest Surg . 2014 Sep 27;6(9):175-82] There are two dimensions in this study: intussusception and PEComa. Therefore, there should be at least two paragraphs in the introduction of the article. First, a few sentences about pediatric intussusception should be written, and then the PEComa section, which is one of the rare causes of intussusception, should be passed. The following articles can be used to explain what Intussusception is and what its causes are: Intussusception due to inflammatory fibroid polyp: a case report and comprehensive literature review.
