Thank you for your suggestion. At present, there are few reports about PPMs, and most of them are case reports. We have not found a study on the root cause of PPMs. Various hypotheses about its origin were mentioned in our discussion. Future studies with larger samples or related animal studies are needed to explore the underlying causes.

Ultimately, 48 patients (including the case reported above) were included in the analysis. If is the case, the number of reference for introduction and discussion is very limited (more than 300 papers are about the topic, albeit not all are case reports or presenting all the requirements to be included in your work.

Thank you for your comments. Please allow me to answer your questions in the following two aspects:

- 1) **About the latest literature you listed**, I am sorry that we may not have retrieved two papers listed by you when we submitted the manuscript. To ensure the integrity of literature review, it is necessary to set our literature search time at the end of 2021. Thus, we have added them to our manuscript.
- 2) We have checked the total number of references. There are over 300 papers on this topic, including 51 papers of PPMS (67 patients); 25 papers of meningiomas; 45 papers of lung metastasis of CNS meningiomas; 30 other primary tumors metastasized to meninges; and more than 150 other papers. Referring to the previous review[1], we set the above conditions to exclude studies that performed only clinical neurologic assessment without a radiologic study. Also, primary extracranial and extrapulmonary meningiomas, pulmonary meningothelial-like nodules, and lung metastasis of CNS meningiomas were excluded from review.

- 1) The present study reported a case with very complete clinical procedure and imaging data, including preoperative enhanced CT examination, PET-CT examination, bronchoscopy biopsy, and postoperative pathological results. There were rare signs of calcification on CT, false positives on PET-CT and errors in our biopsy results. This suggests that we need to be cautious when excluding PPM only through auxiliary examination or even needle biopsy in clinical work.
