1. Avoid using the term "The first case of..." in your title.

2. However, it is recommended to add a column with author(s) – XXX et al., as well as another column with the publishing year for the sake of clarity.

Answer: We have added the authors and publishing year in Table 2, see L377.

3. It would be more persuasive to add a series of gross photographs of the skin abscesses at different phases during the infection process.

Answer: Adding a series of general photos of skin abscesses at different stages of the patient's infection process will indeed make our article more convincing. Unfortunately, for the sake of protecting the patient's privacy, we did not take photos of the patient's skin abscess during the patient's hospitalization. Now the patient has been cured and discharged, so we can't provide photos of the patient's infection process.

4. The colony and microscopic morphologies of B. gladioli are shown in Fig.1A. I would appreciate to see the use of arrows or other symbols that add more detailed information and point the specific area of the plate you want to emphasize. Besides, size bars are missing.

Answer: We have added arrow and size bars in Figure 1a, the arrow indicated a single colony, microscope magnification: 1000×, see L388-389.
