that immunoadsorption combined with glucocorticoid and cyclophosphamide shock therapy has achieved significant efficacy in patients with Klinefelter syndrome complicated with antiphospholipid syndrome. This is indeed a rare and interesting case. The author needs to put forward more explanations for his proposed treatment scheme, which is conducive to the understanding of readers and the dissemination of knowledge. Figure legend should not appear in the figure because it is not conducive to post editing. The choice of the references is outdated. Scientific Quality:Grade C Language Quality:Grade B Recommendation:Conditional acceptance.
