Allocating animals to experimental groups	11	a. Give full details of how animals were allocated to experimental groups, including randomisation or matching if done.	
		 Describe the order in which the animals in the different experimental groups were treated and assessed. 	6
Experimental outcomes	12	Clearly define the primary and secondary experimental outcomes assessed (e.g. cell death, molecular markers, behavioural changes).	6-9
Statistical methods	13	a. Provide details of the statistical methods used for each analysis.	
		 Specify the unit of analysis for each dataset (e.g. single animal, group of animals, single neuron). 	9
		 Describe any methods used to assess whether the data met the assumptions of the statistical approach.
